PEREN

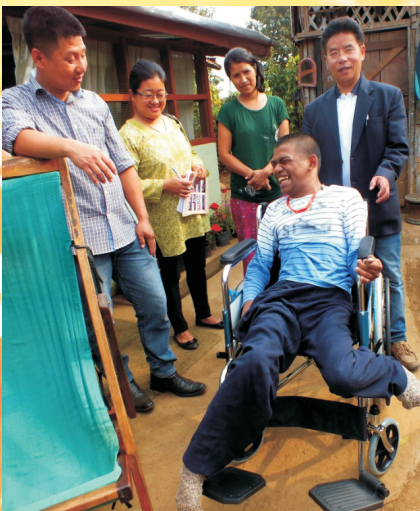
